In the field, anything can happen and maintaining optimal performance of equipment may be challenging, even for newer equipment.

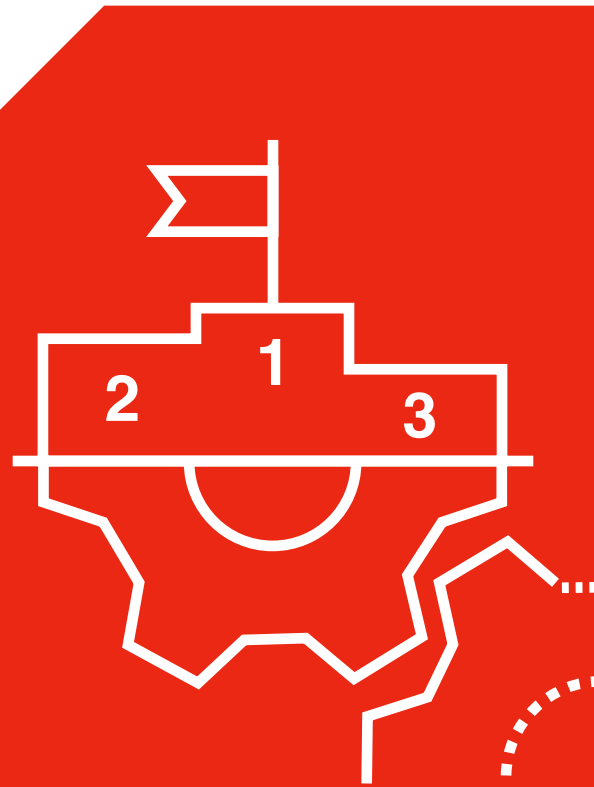

Reduce your financial risk and protect your equipment

EPS is a program to reduce unexpected costs in case of failure of the main components of designated crushing and screening machines. To reduce the risk of failure of the covered equipment's main components, regular inspections and the usage of genuine parts are required. The protection period is 5 years/10,000h*.

EPS is available for designated crushing and screening equipment. Consult with your Metso distributor or sales office for more details.

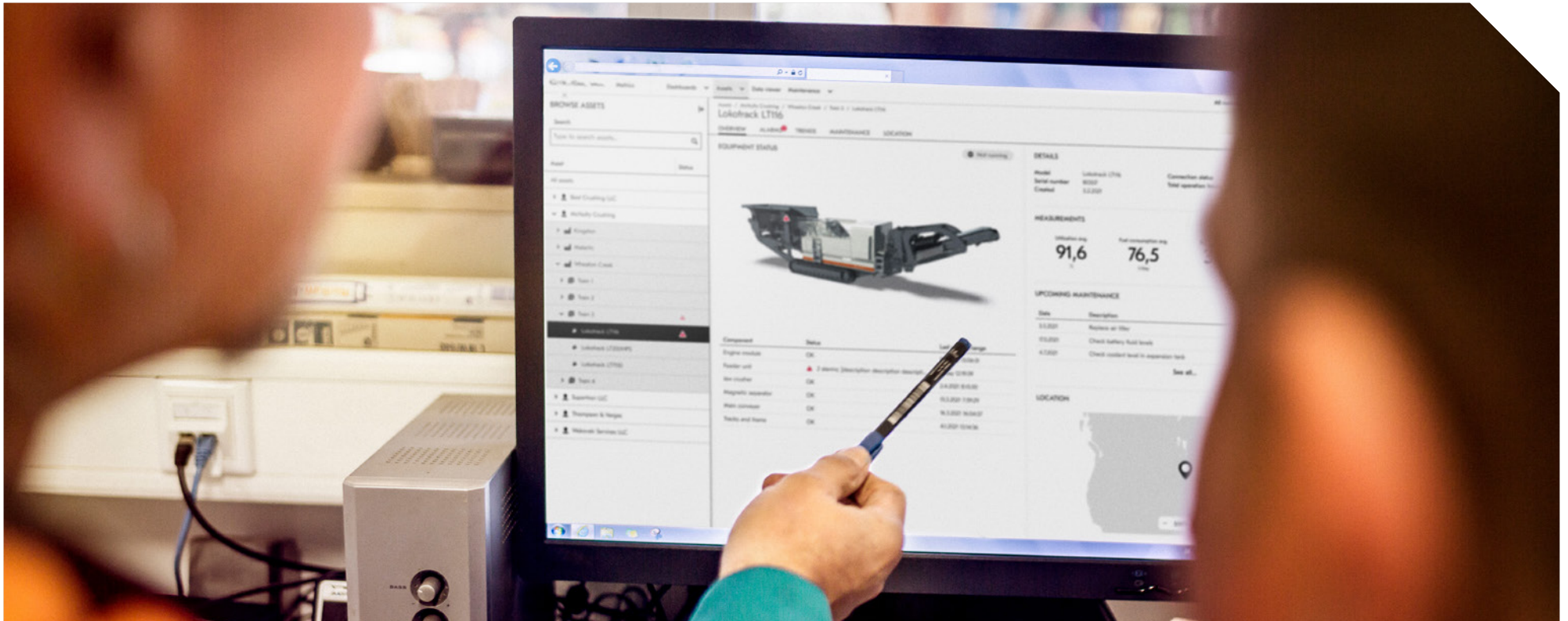
